

CONSENT & INDEMNITY FORM

2019 MAKEX SG ROBOTICS COMPETITION

The 2019 MakeX SG Robotics Competition (the “**Competition**”) is organised by Polaris Network Pte Ltd., co-organized by EP-TEC Solutions Pte Ltd and Sparklife Asia and supported by People’s Association and National Library Board (collectively, the “**Organisers**”).

In consideration of the Organisers agreeing to allow me to participate in the Competition, I, the undersigned, HEREBY COVENANT AND AGREE with the Organisers as follows:

1. I acknowledge and confirm that the nature and type of performances which I may undertake in this Competition are of my own choice and design, and I understand that carrying out such performances and participating in the Competition is POTENTIALLY DANGEROUS and I voluntarily ACCEPT all risk of damage, loss or injury to me and/or my property howsoever caused consequent upon or arising from my participation in such activities. In particular and without limitation to the above, I am SOLELY RESPONSIBLE for ensuring the safety of all such performances/activities.
2. I hereby warrant that I am fit to participate in the Competition and am not presently suffering from or receiving treatment for any illness, disorder or injury which may render it unsafe for me to take part in the Competition.
3. I HEREBY AGREE that I will forever RELEASE AND DISCHARGE the Organisers, their respective related companies and/or third party contractor/supplier(s) from all responsibility, liability or damages whatsoever for any injuries or damage to me, my property and/or any loss of any other kind whatsoever and howsoever caused, due to my participation in the Competition. I agree NOT TO SUE, make any claim or otherwise take any action against the Organisers, its related companies and/or third party contractor/supplier(s) for any injuries or damage to me, my property and/or any loss of any other kind whatsoever and howsoever caused, relating to my participation in the Competition, and I agree to indemnify the Organisers in respect of the same. I agree that this release may be pleaded to any such claim.
4. I will abide by all rules and regulations imposed by the Organisers in relation to the Competition, including but not limited to the Rule Book, and I will comply with all directions of the Organisers’ staff and representatives given at any time during the Competition.
5. In the event that any clause of this agreement is deemed invalid or unenforceable, then the remaining clauses shall remain in full force and effect, and so far as possible, the said clause shall be deemed modified to the minimum degree possible so as to comply with applicable law and be valid and enforceable.
6. I acknowledge and confirm, in the event of being awarded as the Champion titleholder of the stated categories, I will be obligated to represent Singapore in the International Competition held in Guangdong Province expected tentatively in late November/early December 2019. Otherwise, the title / representation will be forfeited and transferred to the next position in line.
7. This agreement shall be governed by and construed in accordance with Singapore law.
